

INTERIM PROHIBITION ORDER

HEALTH COMPLAINTS ACT 2016 Section 90

This Interim Prohibition Order is made pursuant to section 90 of the *Health Complaints Act 2016*.

The Health Complaints Commissioner (**Commissioner**) has made this Interim Prohibition Order because the Commissioner reasonably believes that the general health service provider named below has contravened a code of conduct applying to the general health service being provided and is satisfied that it is necessary to make this order to avoid a serious risk to the health, safety or welfare of the public.

Name of the general health service provider on whom the Interim Prohibition Order is imposed:	Joseph Faralla trading as 'The Massage Doctor' (ABN: 54 271 477 513) of Coburg North in the State of Victoria.
Date of this Interim Prohibition Order:	11 January 2024
Date on which this Interim Prohibition Order expires:	An Interim Prohibition Order can remain in force for up to 12 weeks. This Interim Prohibition Order will remain in force until 3 April 2024 while an investigation is conducted unless it is revoked before that date.
Effect of this Interim Prohibition Order:	<ol style="list-style-type: none"> 1. <i>The general health service provider named above must not, directly or indirectly:</i> <ol style="list-style-type: none"> a) <i>advertise or cause to be advertised,</i> b) <i>offer or cause to be offered,</i> c) <i>provide or cause to be provided, or</i> d) <i>establish, direct or otherwise operate any business that either advertises, offer or provide (or causes to be advertised, offered or provided)</i> <p><i>any general health service, paid or otherwise, in a clinical or non-clinical capacity.</i></p> 2. <i>The general health service provider named above must prominently display a copy of this Interim Prohibition Order at any premises where they provide any general health service and must ensure that it is easily visible to the public.</i> 3. <i>The general health service provider named above must prominently publish a copy of this Interim Prohibition Order on the homepage of any website or social media platform they use to offer or promote any general health service.</i>

In this Interim Prohibition Order 'general health service' and 'general health service provider' have the same meaning as in section 3 of the *Health Complaints Act 2016*.

This Interim Prohibition Order takes effect on the service of the order on the general health service provider to whom it applies.
