

## **INTERIM PROHIBITION ORDER**

## HEALTH COMPLAINTS ACT 2016 Section 90

This Interim Prohibition Order is made pursuant to section 90 of the *Health Complaints Act 2016*.

The Health Complaints Commissioner (**Commissioner**) has made this Interim Prohibition Order because the Commissioner reasonably believes that the general health service provider named below has contravened a code of conduct applying to the general health service being provided and is satisfied that it is necessary to make this order to avoid a serious risk to the health, safety or welfare of the public.

| Effect of this Interim<br>Prohibition Order:   | <ol> <li>The general health service provider named above must not, directly or indirectly:         <ul> <li>advertise or cause to be advertised, or</li> <li>offer or cause to be offered, or</li> <li>provide or cause to be provided, or</li> <li>establish, direct or otherwise operate any business that either advertises, offers or provides (or causes to be advertised, of causest, offered or provided)</li> </ul> </li> <li>any general health service, paid or otherwise, in a clinical or non-clinical capacity.</li> <li>The general health service provider named above must display a copy of this Interim Prohibition Order at any premises where he provides any general health service and must ensure that it is easily visible to the public.</li> <li>The general health service provider named above must publish a copy of this Interim Prohibition Order on the homepage of any website or social media platform he uses to offer or promote any general health service including (but not limited to), the following websites:</li> </ol> |
